The District 57 Education Foundation has surpassed the goal of its year-long Decade of Giving Campaign, bringing the total amount raised in 10 years to more than \$500,000. The much-anticipated announcement came at the Xtravaganza fund-raiser on March 8. The campaign was launched a year ago in celebration of the Foundation's 10-year anniversary this spring. There have been many successful fundraising opportunities over the past year that brought the goal within reach, but the generous sponsors and attendees of Xtravaganza pushed the Foundation over the top.

The Foundation's most important fund-raiser of the year – Xtravaganza – brought in a record \$55,000 that will benefit the students of the four District 57 schools. About 400 people attended the March 8th event, held at Meridian Banquets in Rolling Meadows. Guests enjoyed a casino, live and silent auctions, a band and DJ, a popular "Deal or No Deal" gift certificate giveaway sponsored by the PTA and a performance by the Lincoln Middle School Jazz Band. A highlight of the evening was the drawing for the \$10,000 Grand Prize Raffle. The lucky winners were Robert and Sally Duke, who raised their children in District 57 and currently have grandchildren in the district. They donated a portion of their winnings back to the Foundation. The money raised at Xtravaganza will help fund grants at each of the schools, enabling students to take advantage of learning opportunities that might not otherwise be available to them.
